Create your account and enter LIFEKEYSWA in the Promotional Code field to receive the discounted products.

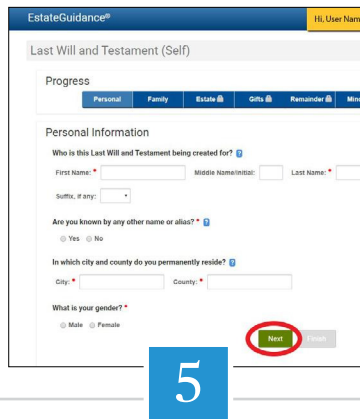

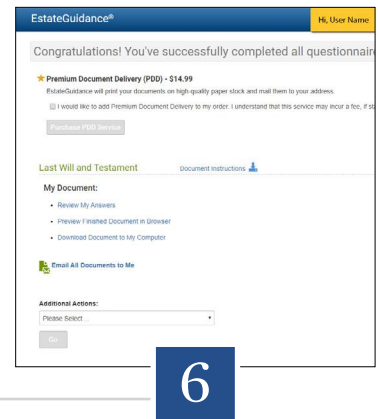
Click **Get Started** under **Last Will and Testament**.
